The core objective of this study is to elucidate the ways in which the castle's unique architectural elements serve as a muse for the creation of dance movements, thereby weaving a narrative thread that connects the historical and architectural legacy of the site with contemporary dance practices. Central to this exploration is the formulation of a dance framework that is deeply ingrained in the castle's iconic motifs, alongside the meticulous selection of dancers who possess the interpretative skill and expressive capacity to embody these motifs. Nestled within the revered precincts of Phanom Rung Historical Park, this artifact heralds a narrative rich in architectural splendor and spiritual maturation. Its origins trace back to the period from 1181 to circa 1220, a time marked by a significant doctrinal shift toward Mahayana Buddhism under the auspices of King Jayavarman VII of the Khmer Empire. This epochal transition not only reshaped the spiritual contours of the region but also underscored the architectural and iconographic magnificence of such relics. The intricate depictions dedicated to Lord Narayana on the lintel underscore the profound impact of Indian culture and spirituality on Southeast Asia, weaving a tapestry that blends art with transcendental significance. This artifact's significance transcends its static grandeur, forging a vibrant connection with the performing arts, particularly dance. In this confluence, the lintel becomes more than an object of veneration; it acts as a conduit between the tangible heritage and the dynamic realm of dance. This synergy opens a dialogic space that bridges the historical with the contemporary, allowing for the reinvigoration of ancient narratives through the expressive medium of dance. Prasat Phanom Rung, with its rich tapestry of iconographic elements, serves as a focal point for examining the depth and diversity of symbolic representation. This exploration extends across multiple art forms, from the intricate narratives depicted in classical frescoes to the symbolic motifs found in contemporary visual media, illustrating a continuity of human expression through symbols (Keister, 2014; Stutley, 2019).

Iconography, as an academic discipline, demands a rigorous analysis of visual symbolism, investigating the myriad ways in which imagery, icons, and symbols communicate complex cultural, religious, social, and historical narratives. Its relevance spans a broad spectrum, encompassing the sanctified depictions in Christian iconography, which offer a window into the theological underpinnings of the faith, to the cryptic symbols of ancient Egyptian hieroglyphs, which reveal insights into the civilization's beliefs and practices.

This artifact, dating from the 15th to the 17th century, is celebrated for its intricate carvings depicting Lord Narayana, a central figure in the Hindu pantheon, thereby offering a window into the spiritual narratives prevalent during its creation. Such depictions not only serve as religious iconography but also underscore the interweaving of mythological motifs with everyday life, reflecting the deep spiritual and cultural imprints of the time (Diskul, 1974; Fine Arts Department, 1988; Woodward, 2005).

Positioned as a heraldic threshold, the lintel symbolizes a liminal space that bridges the earthly with the divine, encapsulating the transcendent aspirations of its creators and worshippers. This liminality is not just architectural but symbolic, marking a passage from the profane to the sacred, thus elevating the lintel from a mere decorative element to a profound semiotic artifact. Its iconography, rich in symbolism, offers invaluable insights into the cosmological views, religious practices, and societal values of its era, making it a focal point for understanding the spiritual zeitgeist that shaped its creation.

The semiotic richness of the Narai Banthomsin lintel extends its significance far beyond its original religious function, embodying a testament to the architectural ingenuity and artistic flourish of its time. Its detailed carvings and symbolic depth reveal the sophisticated aesthetic sensibilities and technological capabilities of its creators, highlighting their ability to fuse form with meaning in a manner that resonates with both contemporary and future generations.

In the realm of contemporary academia, the Narai Banthomsin lintel has evolved beyond its archaeological significance to symbolize the broader challenges and opportunities of cultural preservation. 4.1.3 Archival Compilation: A comprehensive archive is curated, containing critical reflections on choreography, annotated sketches, video records of rehearsals, and visual narratives of the choreographic process. This archive documents the creative journey and serves as a resource for further analysis.

4.2.1 Exhaustive Interviews: In-depth interviews are conducted with the involved choreographers, dancers, and cultural historians. Laban Movement Analysis (LMA) is deployed as the primary theoretical framework for analyzing bodily movements and serves as a fundamental component in the creative processes of designing and choreographing movement. Furthermore, the principles of Laban Notation, recognized for their ability to universally record dance movements, are utilized to ensure that the choreographed and designed movements can be academically substantiated in the future. This notation system promotes universal communication among dance professionals and provides a structured method to verify and preserve choreographic works as academic evidence.

However, this article specifically explores the aesthetic experiences derived from interpreting and finding inspiration in the architectural and sculptural elements of Prasat Phanom Rung for dance choreography. Consequently, it does not focus on the recording aspects of dance movements using Laban Notation. Therefore, the application of Laban Movement Analysis and the recording with Laban Notation are not prominently featured in the research outcomes or detailed discussions of this paper.

The choreographic journey inspired by the iconography of Prasat Phanom Rung unveils a comprehensive and nuanced process pivotal in crafting a performance that resonates with the profound cultural and historical narratives of the site. This process encompasses a detailed examination of dancers' movement capabilities, an intricately designed audition process, thorough analysis of performers' unique attributes, and a careful consideration of gender and dancer typologies within the narrative framework.

**5.2.1 Movement Proficiencies of Dancers and Performers:** The selection of dancers for this ambitious choreographic endeavor was predicated on the identification of individuals possessing not just technical prowess but a deep interpretive sensitivity to the nuanced

movements required by the piece. The complexity and subtlety of the choreography demanded performers who could exhibit a high degree of technical mastery, coupled with the ability to convey nuanced expressions and emotions through movement. The choreographic exploration inspired by the Iconography of Prasat Phanom Rung represents a profound investigation into the intersection of dance, cultural heritage, and artistic innovation. This endeavor underscores the significance of incorporating advanced dance techniques, the pivotal role of improvisation, the necessity for rigorous movement assessments, and the dynamic interplay between individual and collective expressions within the choreographic framework.
