Introduction

National Education Act of 1999, (chapter 4) national educational guideline section 28, Curricular at all levels of education especially the higher education curricular emphasized academic development, with priority given to higher professions and research for development of the bodies of knowledge and society. Furthermore, Section 29, Educational institutions in co-operation with individual, families, communities, community organization, local administration organizations, private persons, private organizations, professional bodies, religious institutions, enterprise, and other social institutions shall contribute to strengthening the communities by encouraging learning in the communities themselves. Moreover, Section 30, Educational institutions shall develop effective learning process, in so doing, they shall also encourage instructors to carry out research for developing suitable learning for learners at different levels of education.
