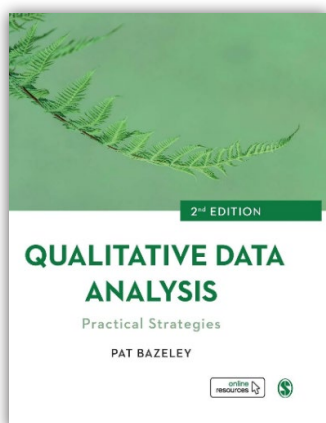


Book Review: Qualitative Data Analysis: Practical Strategies
